THE VALUE OF ONE RUPEE-REALIZED MY STATUS IN THE REAL WORLD BY H.BHOJRAJ

I would like to narrate an incidence which took place on 4^{th} Feb 2017 which made me realize the worth of my status in real life.



I went to the SBI branch in Subramanianagar and withdrew Rs.24000 from my wife's account. The cashier counted Rs.500 notes (32) and Rs.2000 notes (8) and handed over to me. I also counted after getting it in my hand and the amount was Rs.32000 instead of Rs.24000. Immediately I handed over the excess amount Rs.8000 to her and she immediately acknowledged her mistake and profusely thanked me for returning the amount. Other employees commented that only very few honest people do it. I told that the excess amount is not mine and morally I am bound to return it. I returned with satisfaction in my heart that I did the right thing as expected from everyone.

Now the realization story. On the same day evening my wife asked me to get two packets of curd and the main supplier told me it was sold out. I just went a vegetable shop nearby and asked for the curd. She gave two packets and gave her Rs50. Instead of returning Rs10 she told me to buy two lemons since she had no coins. I objected to this since she was forcing me to buy what was not required at that point of time. She immediately took back the curd packets and refused to transact. I again asked her to give one packet and offered Rs.20 stating that I would certainly give Rs.1 the next day. She stared at me and refused to give the curd packet. I told I am staying in the same area for 40 years and I will not cheat her. Then she gave two 200ml packets for Rs.20 which was Rs8 per packet. I lost my temper and dropped the packets there.

Then I went to another shop on the other side of our road and she also refused to give the curd packet if one rupee coin is not given for the Rs20 curd packet. After promising her that I will come back with one rupee within five minutes she handed over the curd packet. I made another round to pay that one rupee which she accepted with stern face and advised me that whenever you come for buying milk or curd always bring one rupee with you.

With a scientist tag, senior citizen tag and acupuncture specialist tag, I could not earn the shopkeeper's trust for one rupee. I could not understand the concept of MRP on the products. Though it happened 7 years back, I am writing this to tell everyone that realization can come at any moment in our life.

When it reaches Lungs, it recognizes the toxins and create phellem and it will remove through the nose. It is better to wait for few days to remove all the toxins from the lungs rather than suppressing the reaction with tablets. A healthy man should get COLD every six months so that all the toxins are removed from the Lungs. If you adopt Allopathy medicine to suppress the reaction these toxins will be shifted to the other organs and will try to come out in different form. The connection between Large Intestine and Lungs was well understood by Acupuncture Specialists but Modern Medicine treats them separately.

WHAT IS ASHWINI MUDRA AND HOW TO DO IT PROPERLY?

Contracting the anal sphincter muscles for few seconds while holding the breath is called Ashwini Mudra. When you do it, the blood pressure will raise. So those who have high BP should do it carefully. In our system we ask the patients to pull the sphincter muscles of the anus while breathing out. Start with just 5 rounds and then gradually increase to 10 rounds. DON'T HOLD THE BREATH AT ALL. The large intestine called Colan consists of Ascending Colon, Transverse Colon, Descending Colon and Sigmoid Colon. With this exercise the sigmoid colon muscles will be strengthened to push it out during peristalsis which occurs naturally between 5 to 7 AM in the morning. If you constipation try to go to the toilet before 7 AM which will be more effective. Solve your constipation and solve your future problems. Have more Luke warm water in the morning and add fiber foods in your diet. **H.BHOJRAJ**

ECZEMA

CAUSES AND SOLUTIONS WITH ACUPRESSURE

WHAT IS ECZEMA?

Eczema is a form of dermatitis characterized by chronically itchy, inflamed skin. The affected area typically becomes dry, the skin flakes off, and occasionally blisters develop. When eczema on fair skinned people, the affected area turns a brownish gray colour. People who have dark skin, it generally alters their natural pigmentation, making the affected area either lighter or darker. Eczema appears most frequently on the face, wrists, elbows and knees but is not limited to those areas.

Eczema, also known as atopic dermatitis affects about 3 to 7 percent of the population and more than 70 % of the patients, it runs in the family. Eczema is often associated with asthma, so children with that disorder may be at greater risk of skin problems. Since eczema may be in part an internal response to some sort of external stress, initial treatment focuses on identifying and reducing possible causes.

WHAT ARE THE CAUSES?

Many cases of eczema are allergy related .In susceptible people, outbreaks can be caused by ingesting certain foods, such as cow's milk, eggs, wheat and nuts-as well as by inhaling airborne irritants like dust mites and pollen.

It may be caused by a change in the way a person's immune system reacts in to a certain kind of physically, chemically, or emotionally induced stress. Any emotionally charged event may trigger a flareup of this disorder.

HOW TO DIAGONOSE?

If the underlaying cause is allergy, it is required to do allergy test and avoid such products.

HOW IS IT TREATED?


Because eczema is generally a benign disorder, and because underlying causes differ from person to person, primary treatment is directed in alleviating symptoms. Home remedies and over the counter medications are usually sufficient. For chronic eczema,

it is better to identify the allergens, building up the immune system and relaxing the body and mind are recommended.

Petroleum jelly application retains the moisture. In severe case hydrocortisone cream will be effective to give good relief. If it is allergy related, oral antihistamines may be prescribed. In severe case, Doctor may prescribe oral corticosteroid medicine also for a short time.

ACUPRESSURE SOLUTION.

Improve the immune system by activating Spleen, Kidney, Intestine, Lungs and Liver points on the palm regularly for 5 minutes every day and activate Liv-3 and St-36 for reducing the inflammation.

CONGRATULATIONS TO TEAM ISRO FOR LAUCHING INSAT 3DS ON GSLV

Really, it is a great tribute to ISRO for the perfect launch of GSLV-F14 which injected INSAT-3DS into a better orbit which will save the spacecraft fuel and extends the life of the spacecraft according to Dr.Sankaran,

Director, U.R.Rao Satellite centre. It is used for enhancing meteorological observations. Monitoring of ocean and land surfaces, weather forecast and disaster warning, as well as to provide to provide satellite aided Search and Rescue Services (SAR) among others.

The Spacecraft carries IMAGER and SOUNDER



payloads, DATA RELAY **Transponders** and Satellite Aided **Transponders** to study cloud properties, fog, rainfall, snow cover and depth, fire, forest smoke, land

and ocean among others.

WHAT IS RADIOMETRY?

Radiometry is the science of measuring light in any portion of the electromagnetic spectrum. In practice, the term is usually limited to the measurement of infrared, visible and ultra violet light using optical instruments. Irradiance is the intensity of light and is measured in watts per square meter.

WHAT IS AN IMAGER? WHAT IS A SOUNDER?

Thermal imager is an electrical observation device, creating the image of temperature difference in an observed area of space. The fundamental component of every thermal imager is a microbolometer array (thermal sensor) and each picture element of this array (pixel) can measure temperature with high precision.

The INSAT-3DR sounder has 18 infrared channels distributed over long wave and short-wave bands along with one visible band. A visible channel provides synoptic view of the clouds and the earth to aid in generating three dimensional maps of temperature and moisture structure of the atmosphere.

WHAT IS VHRR COOLER?

It keeps the thermal sensor at 105 K which is achieved by passive radiation cooling. A heater is also incorporated to heat if it goes down below 105 K. The sensor will be able to measure accurately if the patch is maintained at 105K. ISRO has mastered this technology and produced many VHRR and Passive coolers for INSAT weather satellites.
